## **Town Council Meeting Minutes**

## Business Agenda:

1. It was moved by Dana Wrigley seconded by Byron Wrigley and voted 5-0 approving the minutes of the meeting held June 22nd 2016, and signing the disbursement warrants.

- 2. Council members voted 3-2 (Donald Borman receiving 3 votes and Kelly Couture receiving 2) to support Donald Borman, as a write-in candidate for the MMA's Legislative Policy Committee (LPC) Member. Councilors also approved the MMA voting ballot, as printed, for the election of their Vice President and Executive Committee members as follows: Linda Cohen Vice President, James Gardner, Jr., Christine Landes and Mary Sabins as Directors.
- 3. It was moved by Michael Perkins seconded by Dana Wrigley and voted 5-0 to authorize the Oakland Fire Auxiliary to hold a Toll Booth on KMD on July 23<sup>rd</sup> (Oakfest). Chief Tracy has a safety plan in place for that day and liability insurance has been purchased. The proceeds from the toll booth will be used for the purchase of life saving devices and projects for the department.
- 4. It was moved by Dana Wrigley seconded by Michael Perkins and voted 5-0 to close the Town Parking lot on Center Street from 07/20/16 thru 07/22/16 for the Oakfest activities.
- 5. It was moved by Dana Wrigley seconded by Donald Borman and voted 5-0 to allow a variance to the Noise ordinance by one (1) hour on 07/22/2016 and 07/23/2016, which will extend until 10PM for the OakFest Street Dance on Friday evening and for the bands playing the day of OakFest on Saturday evening.
- 6. It was moved by Dana Wrigley seconded by Byron Wrigley, Sr., and voted 5-0 to approve closing Main Street for all vehicle traffic from Buddies Groceries to the Oak Street intersection from 4PM to 10PM on 07/22/16 (OakFest parade and street dance).

- 7. It was moved by Dana Wrigley seconded by Michael Perkins and voted 5-0 to approve closing the Oakland Public Boat Landing until noon on Sunday 07/24/16 for the OakFest Triathlon. Adequate signage and flyers will be circulated the week prior to the event.
- 8. It was moved by Dana Wrigley seconded by Donald Borman and voted 5-0 to approve the recommendation of the Transfer Station Steering Committee regarding the reissuance of transfer station stickers. Replacing stickers will help to prevent residents from paying for other towns' trash. Stickers will be replaced every two (2) years starting in November at a fee of \$1.00.

## Manager's report:

- 1. Councilors received the Assessor's monthly report for June and July which included tax information relative to the 2016-2017 mil rate from \$15.10 to \$15.50.
- 2. No updates provided on the Old School house by the Oakland Historical Society.
- 3. The Manager updated Council members on the planning progress of OakFest. It was noted that sixty-four (64) units have registered for the parade and there are over 100 food/craft vendors for Saturday.
- 4. It was moved by Dana Wrigley seconded by Byron Wrigley, Sr., and voted 5-0 authorizing the Town Manager to set up a GoFundMe page where individuals may make a tax deductible contribution toward the Gazebo Project.

## Other:

- 1. Councilors received the Library Report.
- 2. Councilors signed the sewer commitment for the user period April May 2016 in the amount of \$136,837.01.
