- 2. It was moved by Donald Borman seconded by Harold Buzzell and voted 3-0 to approve the 2017-2018 Sewer Department Budget in the amount of \$535,953, thus sewer billing charges will remain the same at \$5.25 per cubic unit plus the flat fee of \$50.00. Boyd reported that they have made significant progress in removing ground water entering the sewer system at the following locations: Water Street, Oak Street, Pleasant Street and Allagash Drive. Work will continue to eliminate groundwater in the problem areas in town and checking for sub pumps in the homes.

The audit firm expects to begin their audit in July of August 2017. Their fee for services will not exceed \$5,600.
- 4. It was moved by Donald Borman seconded by Harold Buzzell and voted 3-0 to approve the bid of Somerset Stone of Oakland, in the amount of \$24,050, for the repair/renovation of the front steps at the Library. Prior to starting of the project Somerset Stone requires 50% down.
