Business Agenda:

1. It was moved by Dana Wrigley seconded by Mark Fisher and voted 4-0 to approve the minutes of the November 18th and November 23rd Council meeting, and to sign the disbursement warrants.

- 2. It was moved by Dana Wrigley seconded by Donald Borman and voted 4-0 to reappoint Janice Porter as Town Clerk for 3 years.
- 3. It was moved by Donald Borman seconded by Dana Wrigley and voted 4-0 to reappoint Kathy Geaghan as Assessor for 3 years.
- 4. It was moved by Dana Wrigley seconded by Donald Borman and voted 4-0 to approve the "Order of Discontinuance" of Baker Alley/Baker Avenue as a town way and public easement.
- 5. The Manager reviewed the property tax foreclosure list for 2013-2014. A total of five (5) properties were foreclosed upon November 30th. The Manager recommended placing insurance on two (2) parcels, which include land and buildings, and will investigate the cost of doing so. It was moved by Dana Wrigley seconded by Mark Fisher and voted 4-0 authorizing the Town Manager to proceed with the necessary steps to insure the parcels from liability and loss.
- 6. It was moved by Michael Perkins seconded by Donald Borman and voted 4-0 authorizing the Town Manager to research the possibility of implementing a Town social media site such as Face book. The Manager stated that he would take the responsibility of posting information to the site. There would be no expense to the town and would serve as an advertising tool for posting meetings, events being held, new businesses in town etc.. Councilors requested that the Manager research guidelines, rules and/or regulations for the site. Councilor Borman asked, in addition to Face book, how many other social

media sites are available for possible use by the town. The Manager will report back his findings at a future Council meeting.
