## **Business Agenda:**

- 1. It was moved by Dana Wrigley seconded by Robert Nutting and voted 5-0 approving the minutes of the meetings held on January 9<sup>th</sup>, 2019, and signing the disbursement warrant.
- 2. It was moved by Dana Wrigley seconded by Robert Nutting and voted 5-0 to approve an increase in the Parks and Recreation fees for our upcoming season. Each participant will pay \$50.00 per session from the previous charge of \$35.00. It was noted that there is still a scholarship program available for those in need.
- 3. Councilors continued discussion with Kelly Roderick pertaining to the proposed Senior Center. Kelly stated that she had a number of concerns about safety, who would be in charge of the program, age requirements/eligibility, and the lack of a business model plan. As the group has no business plan nor answers for a laid out plan for citizens and Council members to review it would be premature to approve the request for rental of the room at the school, in the amount of \$3,600 and an additional \$1,100 for the purchase of furniture for the purposed center. Kelly questioned who would own those items if the organization dissolved. Councilors agreed that the proposed center needs additional information and further review by the town.
