Business Agenda:

- 1. It was moved by Dana Wrigley seconded by Robert Nutting and voted 4-0 to approve the minutes of the meeting held on April 24th, 2019, and to sign the disbursement warrant.
- 2. Rick MacKenzie presented the newly revised project budget summary to Council members. It was moved by Dana Wrigley seconded by Harold Buzzell and voted 4-0 to approve the revised Fire Station project budget in the amount of \$2,679,000. Total project budget includes the contingency amount of \$126,717 (4.5%).
- 3. It was moved by Dana Wrigley seconded by Harold Buzzell and voted 4-0 to approve the purchase of the new rescue truck from Greenwood/Warner Bodies in the amount of \$200,000 plus \$11,590.00 for the purchase of two (2) SCBA air packs that will be carried on the vehicle.
- 4. It was moved by Michael Perkins seconded by Dana Wrigley and voted 4-0 to accept the following award "Ed MacDonald Safety Enhancement Grant" for the purchase of a "4 Gas Meter". The grant will cover two-thirds of the cost up to, but not exceeding \$900.45. Because of the towns' interest in workplace safety the MMA Workers Compensation Fund assists with these types of safety efforts.
- 5. It was moved by Dana Wrigley seconded by Robert Nutting and voted 4-0 to hold off on the previous council vote, dated April 24th, which approved the proposed Cable Contract as presented by the Town Manager. The Manager advised Council members that

currently LD 1371 is under consideration pertaining to a model franchise agreement for use by any municipality and any cable system. The Manager will provide updates as they become available.

- 6. It was moved by Dana Wrigley seconded by Robert Nutting and voted 4-0 approving the name of "Warden Way" which is currently associated with the private road name of Candace. Said road is located off the Trafton Road which has four (4) undeveloped lots owned by Delwin Philbrick.
- 7. Council members signed the RSU-18 Warrants calling the June 11, 2019 election.
