- V. Business Agenda:
 - 1. The Manager placed the following agenda article for this meeting "Rescind Dave Groder's vote from January 10th minutes regarding the Fire Department Career Staff." She stated that after reviewing the motion/vote she felt this did not need to be discussed. As the career staff stipends do not involve Councilor Groder, as a volunteer of the Department. Therefore, voting would be permissible as he would not receive a raise, as part of the vote. Kelly Roderick and Anita Chadderton expressed their disagreement with that finding. Roderick stated that she felt that there is a conflict as councilor and a being a paid volunteer firefighter. Stated that "one of them has to go." It was noted that this discussion occurred with the previous Town Manager. A legal opinion was given at that time "if a Town Councilor is not a scheduled employee there is no problem." Councilors asked for another legal written opinion on the matter, which will be discussed at the next meeting, February 28, 2024. Copies of the opinion will be available at that time.
